

## Points to Note for Participants of “Northbound Travel for Hong Kong vehicles” (“NBT”)

Applicants who have obtained approval from both governments and issued a Closed Road Permit (“CRP”)/ e-Approval letter should note: You are required to reserve a travelling date and time slot via the “Specified Dates Booking System” (“SDBS”) before travelling to Guangdong Province via the Hong Kong-Zhuhai-Macao Bridge (“HZMB”) Hong Kong Port on a specified date. The specified days listed by the Transport Department (“TD”) may be updated from time to time. Applicants shall visit the SDBS for details before submitting their application at (<https://qfsl.td.gov.hk/hzmbz/booking.jsp?language=en>).

### **Booking for Travel and Departure**

To ensure the NBT is implemented in an orderly manner, the governments of Guangdong and Hong Kong agreed to introduce a cap on the number of travelling vehicles per day. Vehicles issued with the Mainland electronic vehicle licence and CRP/ e-Approval letter under the NBT must reserve the specified date and time with the SDBS through the NBT thematic website (<https://www.hzmbqfs.gov.hk/en/>) for travelling to Guangdong Province via the HZMB Hong Kong Port on a specified date. The SDBS will begin accepting bookings for specified dates in the following month from the 15<sup>th</sup> calendar day of each month. The reservation will be on a first-come, first-served basis subject to availability.

After successfully completing the reservation, the driver is required to travel to Guangdong Province via the HZMB Hong Kong Port on the reserved date and time. If a vehicle issued with a CRP/ e-approval letter under the NBT travels on a specified date without prior reservation, the law enforcement authorities of both governments may refuse to allow the vehicle to travel to Guangdong Province via the HZMB.

Hong Kong and Mainland authorities may disclose to the TD any information or record obtained during discharge of their duties regarding the applicant’s non-compliance with any requirements of NBT regulations and other laws, including but not limited to the crossing records of vehicles. If any vehicle is found to have violated the travel arrangements, the TD will issue a warning letter/ reminder message to the applicant at the time of the first violation. All non-compliant records will be kept for one year from the date of the violation. If the vehicle is found to have violated the travel arrangements again, the TD holds the right to suspend the eligibility to make travel reservations through the SDBS, or revoke the eligibility for the NBT, or even suspend the eligibility to apply for the NBT again. ### **Preparation before departure**

The driving environment, laws and regulations, as well as road design and traffic direction, etc. vary considerably between Guangdong and Hong Kong. NBT applicants and designated driver(s) should assess whether they have adequate experience, knowledge and ability to drive in the Mainland. Motorists should comply with the Mainland laws and regulations when driving in the Mainland. Before setting off, they should prepare relevant information for travelling between Guangdong and Hong Kong via the HZMB, such as maps and planned routes, and may consider using Global Positioning System (“GPS”) devices to assist their journey.

Applicants and designated driver(s) should read the “Guangdong Province Administrative Measures for Hong Kong Private Cars Travelling to the Mainland via the Hong Kong-Zhuhai-Macao Bridge” (“Administrative Measures”) to understand relevant rules and regulations concerning NBT in the Mainland. If an applicant or designated driver is found violating the Administrative Measures, the Mainland authorities may impose penalties in accordance with the Administrative Measures and they could be subject to punishment by the Mainland authorities. On the date of departure, please ensure all the following documents are carried in the vehicle and readily available for inspection by law enforcement officers:

| <b>Mainland</b>  | <ol style="list-style-type: none"> <li>5. Copy of the “Compulsory Traffic Accident Liability Insurance for Motor Vehicles” or “unilateral recognition” insurance;</li> <li>6. Electronic vehicle licence issued by the Mainland authorities.</li> </ol>  |
